

## Falling Leaves Rough Ride 2021

## **Entry Terms and Conditions**

By entering the 2021 Falling Leaves Rough Ride you are accepting the following terms and conditions;

- You will wear a suitable helmet when riding.
- You will be over the age of 16 on the day of the ride. If unable to provide ID as proof of age if asked participation in the event will be refused.
- You should have a working bell on their bicycle.
- You should be nice and considerate to everyone they come across. Be a shining beacon of an example, proving to the world that cyclists really are a good bunch.
- Obey the Highway Code whenever riding on the roads.
- Follow the Countryside Code when riding on any off-road sections.
- Always ride with safety in mind and within your limits of fitness and skill.
- When riding off-road only use suitable rights of way and give way to other trail users.
- You understand that cycling is a potentially hazardous activity. You understand that cycling and the use of the associated equipment involves a risk of injury to any and all parts of the body. You hereby agree to freely and expressly assume and accept any risks and all injury that may occur on the ride.
- You understand that protective equipment such as helmets and gloves are recommended but they do not eliminate the risk and may not reduce the risk of injury I the event of an accident.
- You agree that you will release the organisers from any and all responsibility of liability for injuries or damages relating to this event.
- You will follow all instructions given by event officials and marshals.
- You will read all event information.
- The entry fee paid is solely for taking part in the 2021 Falling Leaves Rough Ride event and does not include any services or gifts that sponsors, supporters and exhibitors may provide.
- Entry fees are inclusive of VAT. Vat receipts are available on request.
- Any changes to entry details must be made by midnight 1/10/2021.
- PVS Events Ltd will collect participants' personal data to process their entry and contact them via email with necessary updates about the event. Participants have to opt in to receive other emails from PVS Events Ltd. PVS Events Ltd will also hold participants' data in line with track and trace procedures.
- You give permission to use your name, quotes, video footage, photographic likeness for marketing and promotional purposes.

## Cancellation Policy

- If the event has to be cancelled for any reason out of our reasonable control, including but not limited to government imposed restrictions, civil or political unrest, adverse weather conditions, national mourning or terrorist threat, we shall make contact to all participants using the email addresses held in the entry database to notify of the situation. Further notifications may be made through other channels, such as post & social media if deemed necessary.
- If possible, the event will be rescheduled to a date as close as possible to the original date, with all entries being transferred. No refund will be made if the entrant(s) cannot attend the rescheduled date. If a suitable date cannot be arranged by the organiser the event will be cancelled.
- Should the event be cancelled for a reason out of our reasonable control the organisers will issue a partial refund. The portion of the fee refunded is at the sole discretion of the organisers and will take into consideration non-recoverable event costs.
- In the event of a cancellation the organisers are not held responsible for any costs incurred by the entrant(s), such as those related to travel & accommodation.

A 75% refund will be issued until midnight 9/9/2021. A 50% refund will be issued from 10/9/2021 30/9/2021. From 1/10/2021 no refunds will be issued.
